I write in response to your recent request under Virginia's Freedom of Information Act. You seek to be informed of any tax delinquency for failure to pay real estate or personal property taxes on record for the five¹ candidates in the current Democratic primary: Melissa Bondi, Peter Fallon, Libby Garvey, Kimberly Klingler, and Terron Sims. Our records on this matter extend back to calendar year 2004.

Melissa Bondi

Real Estate:

Ms. Bondi did not own any real estate in Arlington for the tax years 2004 through 2011.

Personal Property:

Ms. Bondi had a vehicle registered in Arlington for tax years 2004-2006.

Ms. Bondi was delinquent in 2004, paying the taxes due on October 19 fourteen days after the deadline of October 5.

Ms. Bondi was delinquent in 2005, paying the taxes due on November 28 fifty-three days after the deadline of October 5, following a threat of seizure by the Treasurer's office.

Ms. Bondi's vehicle was reported as sold and removed from the tax rolls in February 2006. Taxes in 2006 were paid by the Commonwealth under the Personal Property Tax Reform Act.

There is no record of any vehicle registered in Arlington in Ms. Bondi's name for tax years 2007, 2008, 2009, 2010, or 2011.

Peter Fallon

Real Estate:

Mr. Fallon owned real estate for tax years 2004 through 2011 and has made all payments in a timely manner.

Personal Property:

¹ A sixth candidate, Elmer Lowe, withdrew on January 2.

Mr. Fallon owned one or more vehicles for tax years 2004 through 2011 and has made all payments in a timely manner

Libby Garvey

Real Estate:

Ms. Garvey owned real estate for tax years 2004 through 2011 and has made all payments in a timely manner.

Personal Property:

Ms. Garvey owned one or more vehicles for tax years 2004 through 2011 and has made all payments in a timely manner.

Kimberly Klingler

Real Estate:

Ms. Klingler partially owned real estate for tax years 2006 through 2011 and all payments have been made in a timely manner.

Personal Property:

Ms. Klingler had a vehicle registered in Arlington for tax years 2004 through 2009.

Ms. Klingler was delinquent in 2006, paying the taxes due on October 11, six days after the deadline of October 5.

Ms. Klingler was delinquent in 2007, paying the taxes due on October 6, one day after the deadline of October 5.

Ms. Klingler's taxes for tax years 2008, 2009, 2010, and 2011 have been paid in a timely manner.

Terron Sims

Real Estate:

Mr. Sims owned real estate for tax years 2006 through 2011 and has made all payments in a timely manner.

Personal Property:

Mr. Sims owned one or more vehicles for tax years 2006 through 2011 and has made all payments in a timely manner.
