Dear Arlington Business:

Effective July 1, 2016, there is an additional 0.25% tourism Transient Occupancy Tax (for Arlington County) in addition to the current 7% Transient Occupancy Tax. For all rentals on and after July 1, 2016, 7.25% of total price paid by the ultimate consumer for the use or possession of any room or space used for lodging should be collected and remitted. The 7.25% includes the local 5% Transient Occupancy Tax, 0.25% tourism Transient Occupancy Tax, and the state 2% regional Transient Occupancy Tax (for the Northern Virginia region).

This mailing contains your updated **2016** Transient Occupancy Tax Returns for the months of July through December 2016. These froms are specifically coded to identify your monthly Transient Occupance Tax payments. If you have a tax preparer responsible for filing your monthly TOT Returns, please forward these returns to their attention and make sure they understand these instructions.

Please Note: Returns postmarked by the U.S. Postal Service after the 20th of each month will be subject to a 10% filing penalty. We rely on the U.S. Postal Service's hand cancelled stamp on your envelope as proof of the date you mailed your return. The post office does not always cancel stamps. We recommend if you're mailing near or on the due date, that you take your return to the post office and personally request a hand cancelled stamp.

PAYMENT OPTIONS:

FILE & PAY ONLINE using our convenient CAPP (Customer Assessment and Payment Portal) system. Filing online will allow you to file your returns faster and more conveniently. To access CAPP and register, please visit the website at https://capp.arlingtonva.us. Payment can be made either by e-check or credit card. A service charge, imposed by our service provider, will apply to all credit card transactions, based on the amount of the payment. There is no service charge for payments made by e-check.

If you file online, but choose to mail in your payment, the date the payment is received will be the recorded date of filing. See "Please Note" paragraph above.

PAYMENT BY CHECK - Simply fill out the correct monthly return and send the return, along with your check made payable to *Treasurer*, *Arlington County*, to Transient Occupancy Tax Program, P.O. Box 1757, Merrifield, VA 22116-1757 using one of the pre-addressed enclosed envelopes. **See "Please Note"** paragraph above.
